Category & Criteria

Young Hotelier Award

1. Applicant must not be older than 38 years.
2. Applicant can be a developer and owner of hotels or an employee on the operations side.
3. Must be actively engaged in the business (development / ownership / operations) activity.
4. Not just the achievement for the relevant financial year but cumulative achievements leading up to the year are considered. Any special achievement or strategic initiatives or significant business development during the year will be a plus point.
5. Applicant must give all the underlying facts and achievements to support the application, highlighting the contribution made by the applicant. We may request additional information where appropriate.
6. Third party recommendations in support of your application are not required.

Young Restaurateur Award

1. Applicant must be in the age group 30-45 years.
2. Must be a first-generation entrepreneur. Normally persons in an inherited business will not be considered unless it is proved that the applicant has substantially transformed and expanded it.
3. The person must be actively involved in running the restaurant business.
4. Not just the achievement for the relevant financial year but cumulative achievements leading up to the year are considered. Any special achievement or significant business development during the year will be a plus point.
5. Applicant must give all the facts of the business including number and nature of units, milestone achievements.
6. In case of restaurant entrepreneur, he/she maybe involved in a standalone restaurant or a chain of such restaurants or in a specialized hotel restaurant.
7. Third party recommendations in support of your application are not required.

Best Manager Awards – F &B; and General Manager

1. Must be in age group 25-40 yrs. (30-50 years in case of General Manager)
2. Must have worked in the hospitality industry for minimum of 5 years (8 years for General Manager).
3. Formal education in hospitality management or an allied field is an advantage but is not essential if other achievements of the candidate are substantial.
4. Must have made a significant achievement during the year in aspects relating to the award; such as financial performance, concept or strategic development, innovation and implementation, business development, successful completion of a project etc.
5. Applicants must submit an application listing out the facts on the above points and special achievement(s) during the year. It must be recommended by the head of the organization/ property who must support the facts and special achievement(s). In the case of chains, it can be the General Manager of the hotel / restaurant and need not be the MD of the company.
6. The employee desirous for applying for the award in any category should have completed 12 months in his/her current job position in the unit from where he/ she is applying for his /her application should be endorsed by the unit General Manager by his physical / digital signature.

Best Chef - Hotel and Restaurant

1. Applicant must have at least 5 years of experience
2. Must be a trained Food Safety Professional.
3. Must have evident Culinary skills (Nominee constantly strives to create innovative and unique recipes, pays close attention to detail to harmonise every ingredient and measurement used)
4. Must have a valid degree/certificate in Culinary arts
5. The employee desirous for applying for the award in any category should have completed 12 months in his/her current job position in the unit from where he/ she is applying for his /her application.
